#### Proposal to EWT Exec and Members

A proposal for a "Returning Officer" (RO), independent of any town, member or country directly involved with a candidate in the officer elections of EWT, the RO to be a Solicitor, or comparable discreet professional, with experience of managing democratic elections.

Anne Scicluna and David Bruce.

To implement the agreed secret postal/electronic ballot for EWT officer elections the following motion is proposed to the Executive and Members of EWT.

Motion:

"that EWT appoint an independent 'returning officer' (RO) to administer a secret election postal ballot. Such an RO will hold the definitive list of eligible of Town Members, will send out a single numbered ballot paper for each Office up for election to each Town Member and will be the postal recipient of all returned votes. The RO will certify the duly returned ballot papers and deliver them counted and assigned to the respective candidates with the declaration of the result in a sealed envelope to be opened at the AGM. A modest honorarium and reimbursement of any expenses incurred will be made to the RO by EWT."

We think this is self- explanatory to ensure the credibility of a secret postal/electronic ballot for EWT elections. Anne Scicluna and David Bruce are in touch with suitable candidate for the post of Returning Officer.

Introducing the AGM and seminar Joe Spiteri wrote "Dear Colleagues and Friends, It is my pleasure to invite you to attend the annual general meeting of the European Walled Towns, which will be held in Ravenna between the 30th September and the 3rd October 2015. In view of the transitional period of the secretariat and following the developments which took place during the last few months, an in depth brain storming of the general situation of our association, changes to the constitution, financial and administrative affairs, the upcoming annual general meeting is in my view of a greater importance than usual..." see full invitation here.

- 11) Action plan for 2015 and a longer term Business Plan.
  - a) the 2015 Action plan is:
    - i) to agree the Constitution compatible with Statutes under the Civil Code. Draft appended for consideration prior to AGM
    - ii) to consider restructured membership. <a href="Proposal appended">Proposal appended</a>. For discussion at meetings in Ravenna Sept/Oct 2015. The proposal provides for special membership conditions attractive to Links and Networks of or containing walled towns and also for a low flat rate fee for any walled town. Some very small existing paid-up member towns would have their fee rate frozen.
    - iii) to launch new website and social media sites for EWT
    - iv) to review longer term Business Plan as discussed and agreed in November 2014 (linked here). This proposal provides for Links and networks of or containing walled towns to

have specific voting membership and also for all walled towns irrespective of size to have a single fee. Certain very small towns which are in paid up membership at the time of the proposed change would have their fee rate frozen

Executive Committee meetings over the last 25 years have almost completely been conducted by consensus. Indeed there have been practically no votes recorded. Membership although defined (rather unclearly) in the Constitution Section 8. has been according to who has been available in the room at the time. Associates have been represented by Vicky Macdonald.

Contentious issues have been deferred, often to the next AGM.

This time many more Members have the opportunity to participate and to contribute to the decisions. However again Joe Spiteri, as President, will be seeking consensus in particular:

First in agreeing to conduct the meeting electronically: any specific objections will be put out to all invitees for comment and if irresolvable and with noticeable support from potentially voting members will be put to a poll. We would expect to complete this formal consent by 19th June. In the meantime we shall continue with further items of the agenda.

Second in agreeing to the co-option of Andre Grima, Medwyn Jones and Tony French.

Third in the matters specifically delegated to this Executive by the AGM XXIV in Chichester September 2014: namely the procedure for Officer Elections by post/electronically.(see Paper for item 8a) If a demonstrable difference of view emerges a poll of voting Members will be taken before 23rd June, the end of this Virtual Exec 47.

Other agenda items can be taken as they come. In the last week, each item will be completed and the minute formulated.
